**Who** Judge Judy

Bailiff Daniel Plaintiff

**News Announcer** 

**When** Present Day

Wear Gavel

(**Props**) Table or desk for Judge to sit at

News reporter microphone

**Why** Daniel 1-6

**How** This skit should be done slightly overdramatically. Don't go overboard, but be

big and have fun with it. This was originally used for a Vacation Bible School drama, so feel free to change the dialogue during the rap if you are not using

this script for VBS.

**Time** 3-4 minutes

**Daniel** is seated stage left and **Plantiff** is on stage right. The judge's "bench" is center stage. **Bailiff** walks into the "courtroom" and addresses the audience.

**Bailiff:** All Rise. Now entering the courtroom is the honorable Judge Judy.

(**Judy** enters and has a seat)

**Judge Judy:** You may be seated.

News Annc: We are in the courtroom where Daniel of Judah will have to defend

his actions over the past few days.

**Judge:** Court is now in session (Bangs the gavel). We will start with the

Plaintiff. (points at him) That would be you.

**Plaintiff:** (Whiney) Well, I've been the King's advisor for ten years

**Judge:** OYE, do ya think you try using your big boy voice?

Plaintiff: (Clear his throat and stands tall) Well, your most excellent honor...um

majesty...I've been working for the king for lots of years. People thought I was cool, and smart and stuff and then that man... (points

dramatically)

**Judge Judy:** Let the record show that he has pointed to Daniel of Judah.

**Plaintiff:** He made me look like a dork-burger.

**Judge Judy:** Let the record show that the plaintiff is a dork-burger. (*Plaintiff pouts* 

and sits)

**Judy:** Okay, Daniel of Judah, what do you have to say.

**Daniel:** (Daniel stands) I don't think he's a dork-burger your honor. (Daniel

sits)

**Judge:** OYE! All right let's move this along. Bailiff, read the counts against

Daniel of Judah.

**Bailiff:** Count #1, Daniel ate all his veggies and would not take the royal

wine. (Whine from all the cast) Not that kind of whine. The plaintiffs feel that Daniel was not being respectful to the king. Count #2, the royal advisors told the king no one could tell him what he dreamed and what it meant. But Daniel did. They feel he defamed their

character.
